# A roller-coaster comes to fruition – EfW facility of Mercia Waste Management to start construction after 15 years of development

Hitachi Zosen Inova marks its eighth project success in the UK

Hitachi Zosen Inova has achieved its eighth project success in the UK as turnkey supplier in its eighth year after market entry and exceeds the 1.5 billion EUR mark for UK order intake.

A Waste Management Services PFI Contract was signed between the Councils of Herefordshire and Worcestershire and Mercia Waste Management Ltd (Mercia) in December 1998 for 25 years. After procurement of the site at Hartlebury estate in 2006 and final planning approval in 2012, Hitachi Zosen Inova was chosen as preferred bidder to act as the Engineering, Procurement and Construction Contractor for the turnkey delivery of the single line 68 MW<sub>thermal</sub> Energy from Waste facility in spring this year, after a long and thorough competitive dialogue tendering process.

## Track record of HZI helps to achieve fast finish

The fact that closing could have been achieved within a short time frame is proof of HZI's experience and reliability as an uncomplicated partner. Franz-Josef Mengede, CEO of HZI commented: "Our eighth success in the UK is a further proof of HZI's leading position in turnkey delivery. The Hartlebury facility represents the new generation of EfW facilities that are part of today's sustainable waste management. For the civil part, always the starting point, HZI found an attractive sub-supplier in the construction division of Interserve, the international support services and construction group. The single line facility achieves a net power export of around 18 MW, enough to power 43'000 households\*. Full and safe compliance with all environmental obligations is a matter of course. Katsuhisa Tsuji, new CTO of HZI is pleased that "the strength of HZI to provide overall optimised solutions based on thorough technology know-how and complex project management experience has led to this most recent success. It is a proof that the co-operation of HZC and HZI, former Von Roll Inova, is a benefit to all parties."

Mercia Waste Management Ltd (Mercia) is a 50/50 joint venture out of FCC Environment Services (UK) Limited and Urbaser Ltd. Both parties have already reference projects on the ground with HZI, including the extension to the Mallorca EfW, where Urbaser and FCC also cooperated.
